Executive Summary

Overview, Purpose and Findings

This Community Needs Assessment provides information about the communities and households served by IMPACT Community Action Partnership and was compiled in 2022. While it was our intent to be as comprehensive as was feasible, we know that we have not captured all of the components that comprise the reality of living in poverty in Central Iowa and that each family's experience has elements that are similar as well as unique.

Key findings from this report are described at the beginning of each section. This report is not intended to provide definitive findings but rather serve as the beginning of a deeper conversation both internally to inform IMPACT's future strategic planning as well as externally both to inform IMPACT's partnerships and to serve as an education tool in conversations with the broader community.

This Community Needs Assessment is intended to take an objective look at the overall demographics of the communities IMPACT serves and areas of need within those communities. Of particular usefulness is data that shows where local trends differ from larger trends by providing comparisons between individual counties, cities and census tracts and IMPACT's service area, the state of Iowa, and the nation as a whole.

About IMPACT Community Action Partnership

IMPACT serves five counties in Central Iowa. Four of the counties are largely rural (Boone, Jasper, Marion and Warren). While the remaining county (Polk) is primarily urban and suburban.

The two longest standing programs administered by IMPACT are the Community Service Block Grant (CSBG) and Low Income Home Energy Assistance Program (LIHEAP). CSBG is intended to be a flexible source of funding that allows local agencies to meet the specific needs of low-income persons in their communities. LIHEAP provides assistance to offset the larger energy bills that result from families heating their homes in the winter months.

Other funding sources include Community Development Block Grant from the City of Des Moines, grants from city and county governments throughout our five county service area - including the Emergency Rental Assistance Program - as well as a number of small, private grants. All of these income streams are vital in helping families meet their most basic needs. Our current programming is focused on the areas of housing, including rent and energy assistance; health, including food and personal products; and local programs, including a variety of programs that are specific to the individual counties of service but also focus on meeting basic needs.

IMPACT Community Action Partnership is guided by our mission and values.

- Mission: Reducing the barriers and burdens that families in poverty experience by increasing access to essential needs.
- Values: Resourceful, Adaptable, Spirit of Service, Passion for the Work and Resolute

Methodology

Data was collected directly from client surveys, customer service assessments, and surveys of community partners. This report will be updated in 2023 with new data from the statewide community action community stakeholder surveys and client surveys.

Data was also collected from the United States Census Bureau; United States Department of Labor Bureau of Labor Statistics; Iowa Childcare Resource and Referral; United States Department of Housing and Urban Development; Eviction Lab; US Department of Health and Human Services Center for Medicare and Medicaid Services; National Center for Education Statistics Massachusetts Institutes of Technology; Common Good Iowa; and Annie E Casey Foundation.

Section 1—Population & Language

Key Findings

Population Changes

All five of the counties IMPACT serves saw their population increase from the 2010 to the 2020 census. However, the counties varied greatly in how much their population increased. Marion, Boone, and Jasper counties all had an increase that was smaller than the statewide population increase of 4.73% for Iowa. In contrast, Polk and Warren counties saw double digit percentage increases (14.34% and 13.37% respectively) and were the Iowa counties with the third and fourth highest percentages of growth.

When population changes are looked at in more detail by examining the Percent by Census Tract map a clearer picture of where population growth has occurred. It appears much of the population growth has been in census tracts that include suburban areas. Though there were census tracts with population growth in urban and rural areas, those are also the areas where the census tracts with the greatest population decreases are located. The census tracts with a population decrease of greater than 10% are located in rural south-central Jasper county, and within the cities of Pella, Indianola, and Des Moines.

Other Demographic Data

Knowing specific demographic information helps us better understand the people we serve and what efforts are needed to make to ensure they are able to access our services. Some key demographic findings include:

- 19.19% of people in our five counties do not identify as "white, non-hispanic."
 - o 23.02% of people in Polk county do not identify as "white, non-hispanic."
 - Less than 10% of people in each of the other four counties do not identify as "white, non-hispanic."
- 14.09% of people in our five counties are 65-years-old or older.
- 24.46% of people in our five counties are 17-years-old or younger
- 11.43% of people in our five counties have a disability.
- 7.41% of people in our five counties are foreign-born.
 - o Approximately 94% of the foreign-born population live in Polk county.
- 6.65% of the over 18 population in our five counties are veterans.
- 32.28% of households in our five counties have children in the household.


- 89% of people in our five counties only speak English at home.
 - o 86.6% of people in Polk county only speak English at home.
 - o 96% or more of people in each of the other four counties only speak English at home.
- 40.7% of people in our five counties who speak a language other than English say they speak English less than "very well."
 - The percent of people who say they speak less than "very well" varies by language and county from a low of 23.4% of Spanish speakers in Warren county to a high of 49.4% of Asian and Pacific Islander language speakers in Polk county.

Total Population Change, 2010-2020


According to the United States Census Bureau Decennial Census, between 2010 and 2020 the population in the report area grew by 69,421 persons, a change of 12.11%. A significant positive or negative shift in total population over time impacts healthcare providers and the utilization of community resources.




Population Change, Percent by Tract, US Census 2010-2020







Population with Any Disability



Section 2—Poverty

Key Findings

Living Wage vs. Federal Poverty Line

Eligibility for most anti-poverty programs is determined as a percent of the Federal Poverty Line (FPL). The Living Wage is an estimate of how much a household needs to make in order to meet their basic needs without any additional assistance. Knowing how the Living Wage for a variety of household types compares to the Federal Poverty Line helps us understand at what levels households need assistance. A couple key comparison points include:

- Of the household types examined within our service area, the household type with the lowest living wage calculation compared to the FPL is an adult living alone with no children in Marion County. The living wage for this household type is more than 2.5x the FPL for this household type (255.32%).
- Of the household types examined within our service area, the household type with the highest living wage calculation compared to the FPL is a single adult with three children in Warren County. The living wage for this household type is more than 4x the FPL for this household type (443.55%).
- The difference between counties for the living wage calculations is fairly small. The largest county difference was for households with a single adult with three children and the living wage estimate for Warren County (the highest) is only 6.44% more than the living wage estimate for Marion County (the lowest).

This also provides context for the poverty statistics in the rest of the report. Those statistics are referring to households at 100% of the FPL (except where specifically noted), but the living wage data makes it clear that these statistics don't tell the full story of poverty in our community. Across IMPACT's five country service area the poverty rate (100% of FPL) is 9.7%, but the percent of people with an income under 185% of poverty is 22.4%

The public assistance income data also shows us that this income is not filling the gap. A small amount of households are receiving this assistance (2.48% across the five counties) and the amount of assistance households are

receiving is fairly small (\$2,971 on average across the five counties).

Poverty Demographics

While recognizing that statistics based on 100% of FPL do not tell the full story of poverty in our community, IMPACT also finds that this data tells us a lot about the households in our community who are most in need of assistance. This data can help us make decisions about our services and our community outreach. Some key findings include:

Geography

o Most of the counties we serve saw a decrease in the rate of poverty from 2010 to 2020, but Polk

- county had a slight increase (0.5%).
- The poverty rate (100% FPL) is lower than the state and national average in all five counties IM-PACT serves. Of the five counties Polk has the highest poverty rate (10.36%) and Warren has the lowest (6.71%)
- o The 185% FPL rate is lower than the state average in four of the five counties IMPACT serves and lower than the national average in all five counties IMPACT serves. Of the five counties Jasper has the highest 185% FPL rate (25.63%) and Warren has the lowest (15.55%)

Race and Ethnicity

- o In IMPACT's service area as a whole the difference in poverty rate (<100% FPL) between racial and ethnic identities is significant. The poverty rate by racial and ethnic identities are as follows:
 - White 7.74%
 - Asian 10.58%
 - Native American or Alaskan Native 16.37%
 - Hispanic or Latino 20.28%
 - Black or African American 27.21%
 - Native Hawaiian or Pacific Islander 32.07%
- When looking at poverty rates by race and ethnicity in individual counties it is important to keep in mind the context that the population of some races and ethnicities in some of the individual counties IMPACT serves is small in comparison, which can result in small numbers causing large changes in percentages.
 - Across four counties the poverty rate for those identifying as white is the lowest poverty rate. Marion County is the exception (likely do to small numbers), but its white poverty rate is in line with the other four counties.
 - Boone County did not have sufficient reporting data for several racial and ethnic demographic groups.
 - Polk County has the highest poverty rate for those who identify as Hispanic/ Latino.
 - Warren County has the lowest poverty rate for those who identify as white, but also has the highest poverty rate for those identifying as Black/African American.
- Gender In each of the five counties IMPACT serves, the poverty rate is higher for women than it is for men.

Household Type

Across IMPACT's five county service area 56.1% of the households experiencing poverty (<100% FPL) are led by a female head of household. However there are differences between the individual counties.

- Similarly to the area as a whole, in Marion, Polk and Warren counties over half of the households experiencing poverty are led by a female head of household.
- In contrast, in Boone and Jasper counties over half of the households experiencing poverty are led by married couples.

Children

- The percentage of children experiencing poverty (<100% FPL) in IMPACT's five county service area ranges from a low of 7.29% in Boone County to a high of 14.08% in Polk County.
- The percentage of children under 200% FPL in IMPACT's five county service area ranges from a low of 20.73% in Warren County to a high of 36.14% in Jasper County
- **Seniors** The percentage of seniors (65+) experiencing poverty (<100% FPL) in IMPACT's five-county service area ranges from a low of 5.5% in Warren County to a high of 8.8% in Jasper County.





CLIENT SURVEY: BASIC NEEDS






Percent Population with Income at or Below 185% FPL





Percent of Poverty Female Householder




Households Living Below the Poverty Level, Percent by Tract, ACS 2016-20











Section 3—Employment & Income

Key Findings

Employment

Unemployment rate changes in IMPACT's five counties over the past five years have generally stayed close to the statewide rate and have followed similar trends to the national unemployment rates while staying below the national rate at each reference point. There are limitations to looking at the unemployment rate as it is a measure of how many people are looking for work, but do not have a job. There are a number of other employment statistics that add additional insight into the employment situation (for example, discouraged workers, people working fewer hours than they'd like). Unfortunately, as of the creation of this report these measures were not available on a county level.

There is more variation in the change in employment data over the past five years. This differs from the unemployment rate in that it is based on the number of jobs instead of the number of people looking for work. A few key findings from this chart include:

- All five counties saw employment decreases in 2020.
- Marion, Polk and Warren counties have seen employment gains in four of the last five years (2020 is the exception) and in 2021 had employment gains of 5.8%, 3.2%, and 5.2% respectively.
- Boone and Jasper counties have each had employment decreases in three of the past five years and the years where they have seen employment increases those rates have been small (1% or less) in comparison to the other three counties.

Income

Data about incomes in our community provide us with useful information about how households in our community are doing. We can compare these incomes to the federal poverty line and to living wage calculations (both included in <u>Section 2</u> of this report) to enhance this understanding. A few key findings include:

- 14.12% of households across IMPACT's five country service area have incomes of less than \$25,000, which is an annual income that falls short of the living wage for all household types in all five counties.
- 35.10% of households across IMPACT's five country service area have incomes of less than \$50,000, which is an annual income that falls short of the living wage for all household types across all five counties except for single adult households with no children.
- The typical salaries in Iowa in most industries in Iowa also falls short of the living wage in Iowa for most household types with children.







Section 4—Education

Key Findings

Educational Attainment

While there are people in our community from all levels of educational attainment experiencing poverty, individuals with lower levels of educational attainment are more likely to earn lower incomes making them more vulnerable to experiencing poverty. Key findings about educational attainment in our community include:

- Boone, Jasper, Marion and Warren counties have lower rates of individuals who have not earned a high school diploma than the state as a whole. All five IMPACT counties have lower rates than the nation.
- There is more divergence between IMPACT's five counties when it comes to their rates of individuals with a post-secondary degree (associates, bachelors, and graduate or professional combined):
 - Polk and Warren counties have higher combined post-secondary rates than the state's rate (47.6% and 43.3% respectively).
 - o Marion county's combined post-secondary rate is the same as the state's rate as a whole (41.1%).
 - Boone and Jasper counties have lower combined post-secondary rates than the state's rate as a whole (40% and 31.5% respectively).
- Jasper and Warren counties have higher rates of veterans without a high school diploma than non-veterans without a high school diploma, while Boone, Marion and Polk counties have the opposite.
- In all five counties (as well as at the state and national level) the rates of veterans with some college is higher than non-veterans, but the rates of veterans with a college degree is lower than non-veterans, which may indicate there are more veterans who start college, but do not have adequate supports to to complete college.
- All counties have seen increases in their high school graduation rates from 2010 to 2019. As of this repost data for the most recent years was not available so we do not know how the pandemic has affected rates.

Preschool Enrollment

Preschool enrollment rates may be related to child care affordability and capacity, which are discussed in <u>Section 5</u> of this report. A couple key preschool findings include:

- Jasper county is the only one of IMPACT's five counties with a rate of preschool enrollment higher than the state-wide enrollment rate.
- All five IMPACT counties have a preschool enrollment rate lower than the national enrollment rate.
- Marion county stands out as having a preschool enrollment rate that is significantly lower than the other four counties (28.22%).

Adult Literacy

An explanation of what the literacy levels mean can be found with the literacy levels chart later in this section. This data may provide insight into where individuals need to be able to access services without being required to read complex statements. A couple key findings include:

- Jasper county stands out as having the highest rate of people at or below literacy level 2, but also has the lowest rate of people at or below literacy level 3, which means they also have the highest rate of people above literacy level 3. They are the only one of the five counties with more than half the population above literacy level 3.
- In contrast, Warren county stands out as having the lowest rate of people at or below literacy level 1, but also has the highest rate of people at or below literacy level 3.

Adult Literacy Level 1

Literacy data published by the Program for the International Assessment of Adult Compentencies (PIACC) breaks adult literacy into five different "Levels". Those reported as Level 1 are at risk for being able to understand printed material. Those at the upper end of Level 1 can read and understand the text well enough to be able to perform small task, but might have difficultly understanding or drawing inferences from multiple forms of text. Those at the lower end may struggle with basic vocabulary or even be functionally illiterate.

Adult Literacy Level 2

Those reported at Level 2 still struggle to perform text based informational tasks, but are considered to be nearing reading proficiency. People in this literacy level can usually be able to read printed words and digital print, as well as being able to relate and make inferences from multiple pieces of information that can be pulled from more than one document. Complex evaluation and inferencing may still be too difficult.

The percentage at or below Level 2 for literacy in the report area is estimated at 31.2%, with a 95% probability that the actual (true, unknown) percentage is between 26.3% and 35.8%.

Section 5—Childhood and Development

Key Findings

Child Care Availability and Affordability

Child Care is a significant cost for households with young children. Data about the affordability and the availability of child care illustrates the challenges faced by these households. Key findings include:

- Child care costs are similar across all five IMPACT counties.
- Across all five IMPACT counties the cost of child care for a single parent with one child who earns
 an income 150% of the federal poverty line would pay more than 25% of their income on child care
 for all types of child care except before and after school care.
- Across all five IMPACT counties the cost of child care for one child for a household earning the median wage in the county is more than 8% of the household's income.
- In Boone, Jasper and Marion counties the estimated number of children under six years old needing child care is greater than the total number of child care spots that exist in the county.






Key Findings

Food and Nutrition

As an essential need, information about access to food is important for IMPACT's work. Some key findings from this data include:

- In the 2020-2021 school year all five IMPACT counties had lower rates of students eligible for free or reduced lunch than the national rate. However, there were significant differences between IMPACT counties. The rates ranged from a low of 23.2% of students in Warren county to a high of 44.9% of students in Polk county.
- IMPACT's five counties fall into two groups for the rate of households receiving SNAP benefits.
 - In Boone and Warren counties 7-8% of all households receive SNAP benefits.
 - o In Jasper, Marion, and Polk counties 11-12% of all households receive SNAP benefits.
- In all five IMPACT counties there are a large portion of households with an income below 100% of the federal poverty line are not receiving SNAP benefits.
 - o In order of the proportion of households with an income below 100% FPL not receiving SNAP benefits the counties' are Marion (46.4%), Polk (49.9%), Jasper (58.2%), Warren (60.3%), and Boone (67.3%).
- The percent of the low income population with low food access ranges from a low of 9.41% in Boone county to a high of 20.61% in Warren county. The census tract map shows that most of the census tracts with the lowest food access are in more rural areas.
- All IMPACT counties except Polk county have lower rates of grocery stores than the state-wide and national rates.
 - The county with the lowest rate is Warren county with a rate of only 7.63 grocery stores per 100,000 people.
 - Since 2010 Polk county has seen an increase in the rate of grocery stores; Marion county saw in increase in the rate of grocery stores in 2012, but by 2020 the rate had decreased back to the 2010 rate; Boone, Jasper, and Warren county each saw a decrease in the rate of grocery stores

Healthcare

Health insurance is considered a key driver of health status with lack of health insurance being a primary barrier to healthcare access. Some key healthcare findings include:

- All five IMPACT counties have lower uninsured adult rates than the national rate. Only Polk county has
 a higher uninsured adult rate than the statewide rate.
- Iowa's uninsured adult rates do vary substantially by race. The uninsured non-hispanic Black rate is
 more than double the non-hispanic white rate. The Hispanic/Latino rate is almost four times the non-hispanic white rate.
- All five IMPACT counties have lower uninsured child rates than the national rate and the statewide rate
- Iowa's uninsured child rates do vary by race. The uninsured non-hispanic Black rate is about 1.5 times the non-hispanic white rate. The Hispanic/Latino rate is over three times the non-hispanic white rate and almost double the non-hispanic Black rate.
- Only Polk and Boone counties have higher rates of adults vaccinated against COVID-19 than the statewide rate and the national rate.
- Marion county has the lowest percentage of adults fully vaccinated against COVID-19 at 64.7% and Polk county has the highest percentage of adults fully vaccinated against COVID-19 at 79.5%

Other Environmental Health Factors

The Centers for Disease Control and Prevention (CDC) has produced a Social Vulnerability Index (SVI) and an Environmental Justice Index (EJI) examining a number of factors that may make a community more vulnerable to disasters and disease outbreaks. The SVI is one of the components that makes up the EJI. Some key findings from this data include:

- On the SVI, all five IMPACT counties have a lower score (indicating less vulnerability) than the US as a whole (0.40).
- On the SVI, Polk county (0.38) has a higher score (indicating more vulnerability) than the other four counties and Iowa as a whole (0.29).
- On the SVI, all five IMPACT have specific census tracts with scores higher than 0.50. Further examination of the map can provide insight into which neighborhoods and communities within our service area may be more vulnerable.
- On the EJI, in IMPACT's four more rural counties the scores for the "built environment" and "housing type" domains score the highest. Both domains score greater 0.6 in all four counties, both score greater than 0.7 in Jasper County, and the "built environment" domain scores greater than 0.7 in Marion and greater than 0.8 in Boone.
- On the EJI, the "potentially hazardous & toxic sites" and "transportation infrastructure" also score highly (greater than 0.5) in Boone, Jasper, Marion, and Polk counties.









Population with Limited Food Access, Low Income, Percent by Tract USDA-FARA 2019





Grocery Stores by Year—Rate per 100,000 by Year, 2010 through 2020








Uninsured Adults by Year



Uninsured Adults by Race/Ethnicity






Uninsured Children by Year



Social Vulnerability Index by Tract, CDC 2018



Environmental Justice Index

Environmental justice is the fair treatment and meaningful involvement of all people, regardless of race, color, national origin, or income, to develop, implement, and enforce environmental laws, regulations, and policies. This goal will be achieved when everyone enjoys the same degree of protection from environmental and health hazards, and equal access to the decision-making process to live, learn, and work in a health environment.

The Environmental Justice Index uses data from the U.S. Census Bureau, the U.S. Environmental Protection Agency, the U.S. Mine Safety and Health Administration, and the U.S. Centers for Disease Control and Prevention to rank the cumulative impacts of environmental injustice on health for every census tract. Census tracts are subdivisions of counties for which the Census collects statistical data. The EJI ranks each track on 36 environmental, social, and health factors and groups them into three overarching modules and ten different domains, as illustrated in the visual on the left.



COVID Fully Vaccinated Adults

This indicator reports the percent of adults fully vaccinated for COVID-19. Data is updated daily from the CDC API. Vaccine hesitancy is the percent of the population estimated to be hesitant towards receiving a COVID-19 vaccine. The Vaccine Coverage Index is a score of how challenging vaccine rollout may be in some communities compared to others, with values ranging from 0 (least challenging) to 1 (most challenging).



Section 7—Housing

Key Findings

Household Composition

Information about housing composition provides greater understanding of how housing affects individuals and families in our community. Key findings include:

- Across IMPACT's five counties approximately 1 in 3 households with children (32.5%) are led by a single adult.
- Across IMPACT's five counties 22.57% of children live in single-parent households. The rate is highest in Jasper (22.13%) and Polk (24.05%) counties.
- Across IMPACT's five counties, households where one senior is living alone make up almost half (42.12%) of all households that include a senior. This rate is lower in Marion County (36.81%) than IMPACT's other four counties.
- In Boone and Polk counties a larger portion of public school students are homeless (1.6% for both counties). IMPACT's other three counties have rates of less than 1%.
- From 2015 to 2020 Boone County has seen its rate of overcrowded housing units decrease while Jasper County's rate has stayed the same and IMPACT's other three counties' rate have increased.

Homeownership and Rental Data

Housing situations for renters tend to be more vulnerable than for homeowners. Homeownership and rental information provides greater insight into housing vulnerability in our community. Key findings include:

- In each of IMPACT's five counties the rate of housing units that are owner-occupied has decreased from 2000 to 2020. In all counties except Warren the rate has decreased by more than 5%.
- In each of IMPACT's five counties the rates of home-ownership are highest for those between the ages of 35 and 84.
- In each of IMPACT's five counties the rates of home-ownership are highest for households that identify as white (over 70% in each county). In each of the three IMPACT counties with sufficient reporting data the rates of home ownership for households that identify as Black is less than 30%.
- Unfortunately, the eviction data available to us is from 2016 and therefore does not account for changes due to the pandemic or new housing programs put in place. In the data that is available the rate of eviction filings is significantly higher in Polk County (8.45%) than the other three IMPACT counties with data (1.64-3.7%). This rate is also significantly higher than the eviction rate in Polk County (2.48%), which is not what is seen in the other three IMPACT counties with data.

Housing Affordability

Housing is a critical need for all and an area where IMPACT has been able to provide additional assistance in recent years. Data about the cost of housing can provide insight into where additional assistance is needed. Key findings include:

- In each of IMPACT's five counties the rate of HUD-assisted units is lower than the rate for the state as a
 whole (317.02 per 10,000 housing units) and the rate for the country as a whole (406.64 per 10,000 housing units).
 - The rates across counties also vary significantly from a low in Boone County of 127.77 per 10,000 housing units to a high of 305.04 per 10,0000 housing units in Polk County
- Across IMPACT's five counties only 30.66% of all housing units are affordable (housing costs not exceeding 30% of household income) to households making 50% of the county's area median household income (AMI).
 - o 40.71% of renter-occupied housing units are affordable at 50% AMI.
 - 24.86% of owner-occupied housing units are affordable at 50% AMI
- Across IMPACT's five counties 24.24% of households are housing cost burdened (housing costs greater than 30% of household income).
 - o The rates are highest in Polk (25.42%), Jasper (22.82%), and Warren (21.64%) Counties.
 - 50.5% of cost burdened households are renters, 38.9% are homeowners with a mortgage, and 10.6% are homeowners without a mortgage.
- Across IMPACT's five counties 9.54% of households are severely housing cost burdened (housing costs greater than 50% of household income).
 - The rate is highest in Polk County (10.2%)
 - 57% of cost burdened households are renters, 34.2% are homeowners with a mortgage, and 8.8% are homeowners without a mortgage.

Condition of Housing Stock

The condition of housing units can have a significant impact on the health and well-being of households. This information provides greater understanding of where households are more likely to be negatively impacted by housing conditions. Key findings include:

- The median year of when housing structures were built ranges from 1960 in Boone County to 1981 in Warren County.
- Across IMPACT's five counties approximately 1 in 4 housing units (24.94%) were rated as substandard and 2 in 15 housing units (13.48%) were rated as having severe housing problems.
 - Rates of substandard housing range from a low of 18.86% in Marion County to a high of 26.22% in Polk County.
 - Rates of severe housing problems range from a low of 9.41% in Warren County to a high of 14.29% in Polk County.











Overcrowded Housing (Over 1 Person/Room), Percent by Tract, ACS 2016- 20

















Owner-Occupied Households, Mortgaged, Totaled by Monthly Owner Costs






Cost Burdened Households (Housing Costs Exceed 30% of Household Income), Percent by Tract, ACS 2016-20

Cost Burdened Households by Tenure, Percent






Severely Cost Burdened Households (Housing Costs Exceed 50% of Household Income), Percent by Tract, ACS 2016-20


Median Year Structure Built by Tract, ACS 2016-20






Owner-Occupied Housing Units by Age, Percentage Report Location





Substandard Housing Units, Percent of Total by Tract, ACS 2016-20



Section 8—Transportation & Internet

Key Findings

Transportation

In all five of IMPACT's counties access to transportation is essential to be able to access work, businesses, community services and more. Public transportation is available in all five counties, but may not meet the needs of all residents. Some key transportation findings include:

- Of IMPACT's five counties, Polk county has the smallest rate of workers with a commute time of less than 10 minutes (13.29%), but also has the highest rate of workers with a commute time of less than 30 minutes (81.21%).
- In Jasper and Warren counties more than a third of workers have a commute time of greater than 30 minutes (36.46% and 38.63% respectively).
- All five IMPACT counties have a lower rate of households with no vehicle than the national rate (8.45%) and only Polk county has a higher rate (6.05%) than the statewide rate (5.68%).
- Across all five IMPACT counties the rate of home-owner households without a vehicle is significantly lower than the rate of renter households without a vehicle.
- In each county 1.22-2.43% of home-owner households do not have a vehicle while 11.05-18.07% of renter households do not have a vehicle.

<u>Internet</u>

Over recent years internet access has become more essential for more households for school, work, accessing community services and more. Some key internet findings include:

- In Jasper and Marion counties over 10% of households and over 6% of the population have no computer. These rates are above the statewide and national rates.
- In Boone and Jasper counties over 6% of the population has a computer, but does not have internet access (7.25% and 6.34% respectively). These rates are higher than the statewide and national rates.
- In all five IMPACT counties more than 96% of the population have access to high-speed internet.
- In all five IMPACT counties access to high-speed internet has increased over the five years we have data for (Dec 2016 June 2021).
- All of IMPACT's five counties have high-speed internet access rates over 95%. Of IMPACT's five counties
 Jasper County has the lowest access to high-speed internet at 96.14%. Jasper County has also seen the
 greatest increase in access since 2016 (78.37%).

















Average Work Commute Time (Minutes), Average by Tract, ACS 2016-20



Households with No Vehicle, Percent by Tract, ACS 2016-20







Key Findings

Customer Satisfaction

Understanding how those we serve feel about the services IMPACT provides helps with decision making around where to focus attention for outreach, staff training and future focus. Some key findings include:

- A majority of respondents agreed or strongly agreed with all seven service statements.
 - The statement with the lowest agreement rating was "I was informed about other services at IMPACT or in the community that could help me." This statement had 76.95% of respondents agree or strongly agree.
- When asked how they would describe IMPACT staff 74.62% said they would use the word "respectful."

Service Delivery

Questions regarding how people would like to be able to access IMPACT services in the future were included to provide understanding on general preferences as well as how important the different service delivery options are to people. These responses were also reviewed by demographics to determine if there were any differences in preferences based on those demographic groups. Some key findings include:

- When asked how they would like to be able to access IMPACT services in the future 69.38% said "by phone" making it the most popular response.
- When examining access preferences broken down by demographics a few things stand out.
 - o By county:
 - ◆ Jasper county respondents were much more interested in being able to access services in person (63%) while Warren county respondents were the least interested in this option (24%).
 - Marion county respondents were much more interested in being able to access services by phone (84%) than all other counties (56-64%).
 - Boone county respondents were less interested in being able to access services online (27%) than all other counties (37-48%)
 - O By Age:
 - For both accessing services by email and online the youngest respondents were the most interested and each older age group was less interested than the previous age group.
 - Interest in accessing services online is split between age groups. Both 18-24 and 25-44
 age groups were less interested in this option (32% and 34% respectively) while the 45-64
 and 65+ age groups were more interested in this option (42% and 40% respectively)

By Race/Ethnicity:

 Most responses were similar across races and ethnicities, but respondents identifying as American Indian or Alaskan Native were less interested in accessing services in person and more interested in accessing services by email.

By Language:

- Breakdowns of responses by languages spoken in the home need to be taken with a grain
 of salt because these results are likely skewed by this survey only being available in English.
- Respondents where English is not spoken in the home were the least interested in accessing services by phone (40%) while respondents where English is the only language spoken in the home were the most interested in accessing services by phone (65%).
- When respondents were asked to rate different ways to access services by how important they were to them a few things stood out.
 - Accessing services in person was both the most important to the most people (34.04%) and the least important to the most people (40.03%).
 - Accessing services by phone was the most or second most important option to the most people (63.16% combined).
- When examining service access ratings broken down by demographics most showed little to no difference in ratings. The one area that did show substantial differences was age.
 - Accessing services in person was the most important to the oldest age group (65+).
 - When looking at 1st choice ratings, accessing services by phone decreases in importance by age, but when 1st and 2nd choice ratings are combined the youngest age group (18-24) matches the oldest age group (65+) at 67% rating as their 1st or 2nd most important option.









Section 10—Community Stakeholder Survey

Key Findings

Community Stakeholders Survey

An updated statewide Community Action community stakeholders survey is being conducted in the fall of 2022. This section will be updated in 2023 with that information. The data included in this report is from the most recent statewide Community Action community stakeholders survey, which was conducted in 2017. It will be valuable to see how the perceptions of community stakeholders have changed in the past five years.



COMMUNITY STAKEHOLDER SURVEY:

Community Stakeholders were asked the open-ended question of the top two things that could be improved in their communities

This question received 195 responses. Stakeholders were able to select multiple responses.







Community Stakeholders were also asked the open-ended question of what they considered to be the top two causes of poverty.

This question received 189 responses. Stakeholders were able to select multiple responses.







Community Stakeholders Feedback

EMPLOYMENT

When stakeholders in our community were asked to choose their biggest concerns regarding employment in their area, 274 responses were given.

- 54% stated that "Not enough jobs pay over \$15/hour.
- 67% felt that under-employment was an issue in their community.

EDUCATION

When stakeholders in our community were surveyed about concerns regarding education in their area, 254 responses were given.

- 47% responded that they believed there was a lack of educational resources for ages 12-17.
- 46% felt that there was a lack of resources for post-secondary education.

CHILDCARE

When stakeholders in our community were surveyed about concerns regarding child care in their area, 251 responses were given.

- 47% responded that they believed there was a lack of child care facilities.
- 66% felt that there was a lack of facilities available for evening, nighttime and weekend care.
- 46% of the stakeholders agreed that there was a lack of child care facilities that provide care for school aged children.

HOUSING

When stakeholders in our community were surveyed about concerns regarding housing in their area, 246 responses were given. They agreed with the following statements:

- 58% Too many abandoned or neglected houses.
- 58% Not enough safe and affordable housing units.
- 62% Not enough safe and affordable housing units set. aside for low-income people.
- 76% Not enough shelters or shelter beds.
- 73% Homelessness is an issue.

TRANSPORTATION

When stakeholders in our community were surveyed about concerns regarding transportation in their area, 247 responses were given.

- 47% responded that they believed there was a lack of daytime transportation services.
- 61% felt that there was a lack of evening, nighttime and weekend transportation services

HEALTH

When stakeholders in our community were surveyed about concerns regarding health services in their area, 244 responses were given.

- 75% responded that they believed there was a lack of behavioral and mental health care resources and services.
- 45% felt that there was a lack of dental health services for those in their community.
